### 1. Aspiration Statement

The Global Center for Innovation and Entrepreneurship (GCIE) is a collaborative interconnected ecosystem of entrepreneurs from early stage ideation to a full life cycle of mature businesses, leveraging regional resources and talent to accelerate the business growth of our community by serving the entrepreneurial needs of all, with a focus on historically marginalized communities.



#### 2. Action Plan

Within the regional map of Northeast Ohio there are approximately 156 plus organizations intentionally designed and inadvertently working to serve entrepreneurs within every stage of development. This vast reach within the entrepreneurial eco-system presents a number of challenges within the region concerning the adequacy of entrepreneurial advocacy, such as:

- 1) Overlapping areas of service
- 2) Lack of clear pathways between service organizations
- 3) Fragmentation of services
- 4) Lack of knowledge within service organizations about other resources
- 5) Narrow focus of existing agencies can inadvertently close off capital and resources to other groups

The Global Center for Innovation and Entrepreneurship is designed to address these challenges by creating a unified location by which each of the respective service organizations are accessible and known to each other in one place. This center, specifically focused, is diverse with the focus on the word "global". Every nationality, creed, color, and socio- economic status is equally and equitably advanced through the Center with an approach that is level and unified for success under a collective body of entrepreneurial advocacy organizations.
